Internal WCCI Grants

ELIGIBILITY

We offer \$1,000 in grants to students who meet any of the following criteria:

- Veterans
- Women
- Black/African American
- Hispanic/LatinX
- Native American
- LGBTQIA+
- Low Income

HOW TO APPLY

This grant is awarded to you upon enrollment if you meet eligibility requirements for our coding bootcamp, and the eligibility requirements listed above.

You may receive a maximum of one WCCI grant AND one WCCI scholarship.

WCCI IT Readiness Grant

ELIGIBILITY

We offer up to \$1,500 for full-stack coding bootcamp students who have graduated from and paid for our PreSkill Programs.

Internal Scholarships

ELIGIBILITY

In addition to our grants, we offer up to \$1,000 in internal scholarships to select students who meet any of the grant criteria (listed under Internal WCCI Grants).

HOW TO APPLY

After enrolling, speak to your student finance representative about submitting a scholarship application. Scholarships are awarded postenrollment if you meet eligibility requirements for our coding bootcamp and the eligibility requirements listed above, and are selected by our scholarship review committee.

NTI Scholarship

The City of Cleveland has chosen We Can Code IT to upskill residents in a handful of neighborhoods. Certain Cleveland-area residents may qualify for a scholarship from <u>Cleveland's</u> <u>Neighborhood Transformation</u> <u>Initiative (NTI).</u>
